GENERAL TERMS AND ACKNOWLEDGEMENTS

TERMS: By enrolling in any of KeirseY's certification training programs ("KeirseY's Certification(s)"), you are authorizing KeirseY to process payment(s) due for your enrollment; and you acknowledge and agree to the terms stated herein. You acknowledge that KeirseY's Certifications are conducted in a manner where only individuals can become certified. If your organization is enrolling more than one individual in KeirseY's Certifications, then any individuals who are enrolled in KeirseY's Certifications from your organization shall be enrolled as a specific individual, and therefore, transferring enrollment from one individual in your organization to another individual in your organization is not permitted. To enroll multiple individuals from your organization in KeirseY's Certifications, each individual must be registered in KeirseY's Certifications.

Participation in KeirseY's Certifications does not guarantee that an individual will become certified. To become certified, an individual must successfully pass a certification exam, demonstrating competence in KeirseY's Temperament Theory and its various applications. To continually retain certification status, you must agree to the ethical standards and principles set by KeirseY. Approval of certification is determined at the sole discretion of KeirseY; and may be revoked at KeirseY's sole discretion if you have breached any terms of KeirseY's Agreement with KeirseY Administrators. You acknowledge that becoming certified does not provide you with the license to certify others in any of KeirseY's Certifications. KeirseY's Certifications are provided solely by KeirseY. If you participate in KeirseY's Certifications, You have the right to inform others of the training you have received, and upon successful completion of the certification requirements, you have the right to inform others that you have become certified. These terms are subject to change at the sole discretion of KeirseY at any time for any reason.

If you are registered for a Live Training program, and you are seeking to reschedule to another scheduled class, you may request a transfer to another scheduled class if the request is made in writing at least sixty (60) days prior to the originally confirmed date for the Live Training session. Payment(s) already made by you may be applied to another Live Training date for a transfer fee of ten percent (10%) of the total course fee paid by you. A transfer fee is charged each time a transfer is made by you. A maximum of two (2) transfers is allowed, and you must participate in a Live Training within six (6) months of the date you enrolled. In the event that such conditions mentioned herein for transferring to another Live Training class by you is not met, you forfeit the right to attend a Live Training session, and no refunds shall be provided to you.

If you are registered for a Virtual Training, rescheduling may be permitted by contacting KeirseY (pursuant to any other applicable written agreements between you and KeirseY). No refunds are provided for cancellation requests made by you for KeirseY's Certifications. Once enrolled, you will have six (6) months to access and complete the certification training program you are enrolled in (the "Training Period"). After the Training Period, you forfeit your enrollment and no refunds shall be provided. Should an extension be granted by KeirseY to you beyond the Training Period (at KeirseY's sole discretion), additional charges may apply.

You may not transfer your enrollment to another party. All materials for KeirseY's Certifications provided to you shall only be accessed by you; and in the case that your organization has multiple individuals enrolled in KeirseY's Certifications, only the registered individuals from your organization may access their own individual materials. If KeirseY cancels or reschedules any Live Training class, for any reason, you will be offered the opportunity to enroll in another Live Training class which KeirseY indicates is available, or you shall have the option to enroll in another format of KeirseY's Certifications offered as an alternative to you. KeirseY shall not be responsible for any losses incurred by you for any cancellation or rescheduling made by KeirseY of a Live Training class.

Individuals who have successfully become certified in any of KeirseY's Certifications are referred to as a Certified Partner. The title Certified Partner means that you belong to a network of professionals who have successfully completed a certification program offered by KeirseY; provided however, that in the case that your organization has multiple individuals who have successfully completed the certification program, only those individuals will be referred to as Certified Partners; your organization will not be considered a Certified Partner. If an individual who is a Certified Partner leaves to another organization, the Certified Partner status will leave with them to the other organization. There is no intent that a Certified Partner creates an employer/employee relationship, a franchise, joint venture, fiduciary, or partnership between KeirseY and you.
